Department of International Trade Promotion (DITP) and the Gem and Jewelry Institute of Thailand (Public Organization) or GIT will jointly organize the Bangkok Gems and Jewelry Fair (BGJF) for two editions in 2025 at Queen Sirikit National Convention Center (QSNCC). The event dates are as follows:

- ❖ The 71st Bangkok Gems & Jewelry Fair during 22 – 26 February 2025
- ❖ The 72nd Bangkok Gems & Jewelry Fair during 9 – 13 September 2025

Please be informed that the floor plan for the 71th & 72nd BGJF will be re-zoned. International Zone will be divided as International Gemstone (LG floor) and International zone (G floor), which results to a relocation of all booths.

The criteria for booth allocation for oversea exhibitors participated in International zone or International Gemstone zone will be principally considered as Group of Country based on the number of booth paid and date of full payment by deadline. Please note that the organizers reserve the rights to refuse any payment made after the deadline.

Participation fee for Raw space 9 Sqm. (3*3 m.) : 4,000 USD

Special promotion rate for 2 editions (The 71st & 72nd BGJF) : 3,500 USD /Raw space/Edition

Therefore, we would like to invite you to register for the BGJF 2025. Registration will start from 9 September 2024 onwards. Please find attached schedules as follows:

- Registration date : 9 – 30 September 2024
- Payment date : 8 – 25 October 2024
- Booth allocation : 15 – 30 November 2024

Exhibitors are able to register for joining the BGJF 2025 at Queen Sirikit National Convention Center, during 9 – 13 September 2024 at Reserve space, LG Floor in front of Hall 7.

Criteria for participation with the 71st & 72nd Bangkok Gems & Jewelry Fair 2025

1. Approval of applications: the organizer will approve applications based on the date and time of submission.
2. The exhibitors who participated in the 69th & 70th BGJF and apply for 71st & 72nd BGJF during 9 – 13 September 2024 will have priority to participate with both editions.
3. The queue of booth allocation will be based on the number of booth, date of payment and appropriation of booth decoration. Once payment is made, the booth size cannot be increased or decreased.
4. If the payment is not made within the specified deadline, the organizer reserves the right to automatically cancel the application. Applicants will need to reapply and will be processed in orderly.
5. Exhibitors who submit their applications for two editions (71st & 72nd BGJF) will be approved first.
6. Exhibitors who apply for both 71st & 72nd BGJF with special rate will be at the same location for both editions. Please note that booth locations cannot be changed, increased, or decreased for any reason.
7. **If exhibitors apply only for the 71st BGJF and need to reapply for the 72nd BGJF later, they will be grouped as new applicants for the 72nd BGJF, and need to reselect booth location upon date of payment and space availability.**
8. Exhibitors can select booth locations based on the amount of payment paid.
9. Exhibitors can only display their products according to the exhibit zone specified in their application. In case of failure to comply with this requirement, the organizer reserves the right to terminate participation with no refund.
10. Exhibitors must ensure that all contact information provided in the registration system is accurate and up-to-date. This is important for necessary updates and for handling any related matters. The organizer will not be responsible if you miss any information due to incorrect contact details.
11. Once exhibitors confirm their registration with the 71st & 72nd BGJF, they acknowledge and agree to all terms, criteria, and regulations of participation.
